This information notice is provided in compliance with Articles 13 and 14 of EU Regulation 679/2016 (hereinafter (the "Regulations")), to participants in the "GANDINI SIGN YOUR TASTE THE TASTE" (hereinafter: "participants" or "participant") promoted by Gandini Antonio S.S. Orticoltura Società Agricola, Via Sant'Andrea 23, 46040 Guidizzolo, MN, VAT no.: IT 01874740200, henceforth for the sake of simplicity Gandini, Personal Data Controller (hereinafter: "Controller"), and aims to purpose of describing the methods of management of the initiative with reference to the processing of personal data personal data, and to allow Users to know the purposes and methods of processing of personal data by the personal data by the Controller in the event of their being provided. The services offered by the Controller are addressed to persons aged 18 years or over. Should the Controller become aware of the processing of data of minors under 18 years of age, the Controller reserves the right to unilaterally terminate the use of the service offered as well as to delete the data acquired. The Data Controller, pursuant to and in accordance with of the Regulation, makes it known that the aforementioned legislation provides for the protection of physical persons with respect to to the processing of personal data, and that such processing will be based on the principles of correctness lawfulness, transparency and protection of confidentiality and fundamental rights. The personal data provided by Users - through participation in the initiative - will be processed with their consent are the following: name, surname, address, email, tel, tax code. The purpose of the service is to reimburse to the participant not satisfied with the product the amount spent and to provide him, through the use of the e-mail address provided during registration, information on products and services developed by Gandini and services developed by Gandini.

Methods of processing and storage of personal data

The Controller ensures that personal data are processed in full compliance with the Regulation, by means of manual, computerised or telematic systems. Processing may also be carried out by means of automated tools to store, manage and transmit the data. The data collected and subject to processing will be protected by physical and logical methods such as to reduce to a minimum the risks of unauthorised access, dissemination, loss and destruction of data, pursuant to Articles 25 and 32 of the Regulation. Data processing will last no longer than is necessary to fulfil the purposes for which they were collected. Pursuant to Art. 7 paragraph 3 of the Regulation the data subject has the right to obtain at any time the withdrawal of consent to the processing and request the deletion of their personal data, by sending notice to the Data Controller at: info@gandiniantonio.com. Following the User's request for cancellation, all personal data Following the User's request for cancellation, all the User's personal data will be deleted, without prejudice to any further storage required by regulatory obligations.
